New Business

Dr. Reeves presented several proposals from the Academic Affairs Committee.

For Notification Memos, Dr. Reeves first presented a

Sciences, BS Biology, BS BSN, BS Computer Science, BS Health Sciences, BS Health Services, BS IT, BS Math, BS Rehab Science, BS Respiratory Therapy completion, BS Respiratory Therapy completion, BS RN to BSN, and BS Social Work.

The modifications for the above listed programs have been received by the Senate for notification and no objections registered.

Dr. Reeves presented a new policy for Math Learning Support. Dr. Stines made the motion, and Dr. Hagler seconded. Dr. Reeves explained that the proposed policy would place STEM majors in MATH 1101 instead of MATH 1001 in order to better prepare them for MATH 1111 (college algebra). The policy also changed the GPA for not requiring Learning Support with MATH 1101 from 3.2 to 3.4. There were no questions. The vote was 23 in favor, 0 opposed. The proposal passed.

Dr. Taylor made a motion and Dr. Baker seconded to consider the Minor in Coaching and the Certificate in Coaching together. Both of these programs are intended for students who want to both teach and coach middle or high school, and allow them to be better prepared when they enter the workforce. The question was asked about the difference between the minor and the certificate. The certificate is not tied to a degree while the minor is; the certificate then is more intended for someone who has already graduated, while the minor for is for students wanting another credential with their teaching degree. The question was also raised about how much or whether strength and conditioning had been considered as being part of these programs. Dr. Hagler said that courses like intro to exercise, and nutrition and wellness had options to include those areas, A sports psychology aspect is also included. The vote for these two proposals was 24 in favor, none opposed. The proposals passed.

Dr. Reeves presented a program modification for the MAT. Dr. Hagler made the motion to consider; Dr. Walker seconded. Dr. Reeves explained that the changes were to bring the learning outcomes in line with new legislation concerning literacy as well as professional standards. The vote was 27 in favor, 0 opposed. The proposal passed.

Dr. Reeves presented a modification to the MS in IT. Dr. Walker made the motion to consider it, and Dr. Hagler seconded. The requirement for IT 6620 is being replaced with a choice from three courses in order to add more interdisciplinary options. The vote was 24 in favor, and 0 opposed. The proposal passed.

Dr. Reeves presented a modification to the BS in Rehabilitation Sciences. Dr. Halger made the motion to consider, and Dr. Guyse seconded. The proposal replaces the graduate school track with sports medicine as a track. A teach-out plan is in place for those students in the current program. There is also an administrative adjustment, renumbering RHAB 4250 to 3250 to make the foundation level course less confusing. The vote was 25 in favor, 0 opposed. The proposal passed.

Dr. Wallace had two proposals from the Executive Committee to present.

The first proposal addresses a change in the ex-officio membership on the Academic Quality

Dr. Patillo said that he felt the situation seemed more like something that could be addressed by

breaking vote to oppose the proposal. The proposal did not pass, and the committee will remain in place. Dr. Camara observed the need for further discussion. Dr. Dubuisson said the Senate will need to address how to empower this committee, and Dr. Taylor said that since the proposal was voted down, the Executive Committee could re-introduce it eventually, or the Senate could set up an ad hoc committee to review the matter. Further discussion should be done at a later time. Dr. Wallace said that he will not reintroduce this proposal. Instead, he will propose a proposal to the Executive Committee for deactivating a standing committee as necessary for the next Senate meeting. That would likely mean one proposal for deactivating both the ICPA and the previous committee the Senate voted to deactivate but has yet to be affirmed by Dr. Blake. Dr. Dubuisson Dr. Camara asked who would have access to the results. Dr. Dubuisson said the results would be public. Dr. Camara said that than maybe there should be a note added to the survey for transparency on the data resulting from the survey being made public.

Dr. Dubuisson made a motion to table the question of the survey until an ad hoc group could review it and report back by the first April meeting. Dr. Bousum seconded. The vote was 23 in favor, 0 opposed. The survey will be tabled. Dr. Taylor and Dr. Rogers volunteered to serve on the ad hoc committee with Dr Dubuisson.

Mr. Agnew made a motion to conclude the meeting; Dr. Hall seconded. There were no objections, and the meeting adjourned.
