R at i ordModi fi at i :onThis substantive change request is for the renaming of the "Early Childhood Education" portion of the title of undergraduate and graduate degrees to "Elementary Education." Each institution is listed on the attached sheet, which indicates the institution, the current degree title and CIP code, and the proposed new degree title and new CIP code (if appropriate).

These changes are necessary for two main reasons:

1. Appropriate name for the degree to reflect the age/grade levels (grades P-5) addressed in the degree and for which certification is obtained through the Georgia Professional Standards Commission.

2. Significantly reduce the confusion that TCSG graduates experience when they apply to USG institutions with teacher educator programs. These TCSG students often complete an Early Childhood Education program designed for students wanting to work with students from birth to age 5, often in Head Start and child care centers. Generally, Early Childhood Education Program graduates are certified to teacher in grades P-5, not with children aged birth – 5. There are only two such undergraduate programs in the state that prepare graduates to work with students aged birth – 5. TCSG students often enroll in the other USG institutions with programs with "Early Childhood Education" in the title, thinking that the program that they completed at a TCSG institution has prepared them to enroll in an Early Childhood Education Program. It has not, and students maintain that they would not have enrolled at the institution had they known that this were the case – despite the best efforts of the TCSG and USG institutions to inform students about their appropriate degree options.
